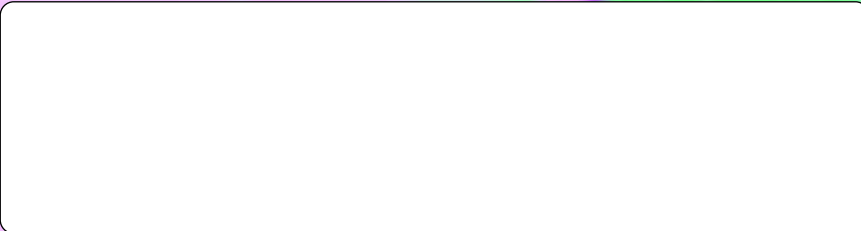

Dear Sir,

National Medical Commission Bill has been sent to Parliamentary Standing Committee. IMA opposes NMC in its present form. We the representatives of all the modern medicine doctors appeal to you to consider the following points.

**Private Medical Colleges :**

1. NMC is a pro private management bill paving the way for widespread corruption. It removes all the regulations before starting a medical college. No one needs any permission.
2. Any private medical college can raise its UG/PG seats by itself.
3. Only upto 40% of seats in a private medical college can be regulated by the Government. For 60% or more seats the private colleges will fix the rates.
4. Huge loopholes in financial penalties ranging from 5 crores to 100 crores opening the flood gates of corruption.
5. As a result medical education in the country will become expensive placing the lower socio economic groups in great disadvantage.

**Privileges of the states**

1. Only 5 states will be represented in NMC at any point of time. The other 24 will be unrepresented.
2. The state medical councils which are sovereign bodies through enactment of state legislatures will come directly under NMC.
3. The universities do not have a representation in NMC. One per state will be represented in an advisory body called Medical Advisory Council.

**Crosspathy**

1. Unscientific mixing of systems will endanger the lives of patients.
2. Provides separate registration and bridge courses for AYUSH practitioners to enable them to practise modern medicine.
3. Joint medical council meetings will ensure mixing the curriculum of all the systems.

**Foreign Medical graduates**

1. Any foreign doctor can practise in India without any restriction.
2. The screening test for Foreign Medical Graduates has been abolished.

**Indian Medical Graduates.**

All Indian Medical graduates should undergo a licentiate exam to be allowed to practise.

**Undemocratic non representative.**

1. Out of 25 members only 5 will be elected and they are part time with no power to him.
2. A group of non medical members are included
3. All the non elected members will be either Government officials or nominated by the Government.

This bill is anti people since it is pro rich and pro private managements. The cost of medical education and healthcare will raise astronomically. It is anti patient since it promotes unscientific mixing of systems. It closes the gate for Indian Medical graduates while opens the gate for foreign doctors and foreign educated medical graduates.

A medical Bill without the concurrence of the medical profession will be a disaster. We appeal to you to call IMA as a major stakeholder for discussion & addressing the objections with visionary outcome acceptable to the fraternity. In the view of medical education & healthcare of this Country it is imperative to address these serious objections raised by IMA.

## NATIONAL MEDICAL COMMISSION BILL, 2017

The following are the main objections of IMA to NMC Bill:

1. NMC is a pro-private management Bill paving the way for widespread corruption. It removes all the regulations required to start a medical college. Under this Bill, no one needs any permission to start a medical college. Also, any private medical college can increase its UG/PG seats by itself.
2. Only upto 40% of seats in a private medical college can be regulated by the Government. For 60% or more seats the private colleges will fix the rates which means that the poor students from SC/ST classes will be deprived of medical education.
3. Huge loopholes in financial penalties ranging from 5 crores to 100 crores opening the floodgates of corruption.
4. Medical Education in the country will become expensive placing the lower socio economic groups in great disadvantage.
5. Only 5 States will be represented in NMC at any point of time. The other 24 will be unrepresented thereby denying them their privileges.
6. The State Medical Councils which are sovereign bodies through enactment of State legislatures, will come directly under NMC.
7. The Medical Universities do not have a representation in NMC. One per state will be represented in an advisory body called Medical Advisory Council.
8. A Medical Bill like NMC without the concurrence of the Medical Profession & Medical Association, will be a disaster.
9. This Bill is anti-people since it is pro-rich and pro-private managements. The cost of medical education and healthcare will rise astronomically.
10. It is anti-patient since it permits & promotes unscientific mixing of systems of medicine. It closes the gates for Indian Medical Graduates while it opens the gates for foreign doctors and foreign educated medical graduates

**Following are the detailed explanations about the objections:**

### 1. AYUSH empowerment –

**Separate National Register:** As per section 55(2)(zl) the EMR Board shall maintain a separate National Register including the names of licensed AYUSH Practitioners who qualify the Bridge course referred in Section 49(4) in such manner as may be specified by Regulations. By an explanation, AYUSH Practitioner has been defined as a person who is a practitioner of Homeopathy or a practitioner of Indian Systems of Medicine as defined in Clause (e) of Sub-section 1 of section 2 of the Indian Medicine Central Council Act, 1970.

As per section 55(2)(zl) of the Bill, the EMR Board shall maintain a separate National Register including the names of licensed AYUSH. The names of the BAMS and BHMS graduates are already registered with their respective councils. On availing the Bridge course, they would be incorporated in a separate register maintained by the Medical Commission, which would mean that they would be having dual registrations with two registering councils, which is neither open nor permissible. Further, the disciplinary jurisdiction on such persons with reference to



breach of ethics is not indicated in the proposed bill as they have dual registrations to their credit. As such these are the flood gates that have been opened up in terms of the statutory provisions for backdoor entry into medical profession entitling practicing modern medicine

IMA Demands that the provision for maintaining separate National Register for AYUSH in sec. 55(2)(zl) should be deleted.

Section 49(4) contemplates bridge courses even for the practitioners of homeopathy to enable them to prescribe such modern medicines at such level as may be prescribed. **This is materially inconsistent with the definition of the word ‘medicine’ as depicted at section 2(j) wherein it is defined as ‘medicine means modern scientific medicine in all its branches and include surgery and obstetrics but does not include veterinary medicine and surgery’.**

**As such these are the floodgates that have been opened up in terms of the statutory provisions for backdoor entry into medical profession entitling practicing modern medicine.**

The First Health policy document in 1943 by Dr. John Bhole established 3-tier system of health delivery and declared MBBS as the minimum qualification to practice modern medicine. Subsequently all the RMPs, LMPs and other short term courses in Modern Medicine were abolished. The government through NMC is going to bring back crash Courses leading to registration to practice modern medicine. This is a retrograde step and highly detrimental to public health. If AYUSH is to be promoted, AYUSH doctors should practice their own system and not mixopathy.

Crosspathy will definitely wipe out pure alternate systems of medicine and deny the public the benefit of alternate systems of medicines.

AYUSH empowerment will substantially reduce standards of Modern Medical Practice hence should be withdrawn. AYUSH empowerment will discriminate people at ground level and does not address the problem of improving the health of the rural people. AYUSH empowerment will play with the safety of the patients.

AYUSH empowerment will deny rural populations the service of MBBS doctors thereby promoting discrimination in health care (between rural and urban health care).

Health of the population depends on various factors including Preventive eg. Immunization, Curative and Social Determinants of health e.g. Nutrition, safe drinking water, sanitary latrines, environmental and personal cleanliness, level of atmospheric and water pollution. Health of the population also depends on the ratio of total health delivery manpower and population and not on doctor population ratio. Allowing AYUSH doctors to prescribe modern medicine will only cause decline in health care standards.

Allowing other systems of health personnel eg. AYUSH to man sub centres and PHC preventive health will be a catastrophic, since they do not believe in immunization and other preventive aspects of modern medicine.

### 2. MEDICAL EDUCATION

Medical education will become unaffordable to ordinary students by allowing 60 percent of the seats to management. Moreover among the total medical colleges now 60% are in private sector which will prevent poor students to get admission to the MBBS course due to high fee structure.

Moreover, NMC only mentions upto 40% of the seats will be under the Govt. control which can be interpreted as 0 to 45, that means the Govt. can either have no (0) Control over the medical seats or





upto 40%. Withdrawal of many regulatory clauses will bring down the minimum standards in medical education.

3. **The NMC draft bill is legally Unsound** since for every provision to maintain transparency, highest standards and autonomy there are several escape clauses which will jeopardise the very objectives of the bill.

**Discretionary Powers for relaxation of prescribed regulatory conditions:** Under Section 29 (d) a proviso is provided which entitles the **MAR Board to relax the criteria for opening of the medical colleges** at its discretion with the previous approval from the Central Government which wields not only a wide authority but also provides adequate scope for availing the discretion for extraneous considerations. More so the regulatory stipulations which are mandatory in nature and binding in character cannot be open for any concession or condemnation vide discretionary authority.

**This will only open the floodgates for sub standard medical colleges which is the reason for overburdening medical graduates with NEXT.**

**The said discretionary authority is not only vested with the autonomous board but also is with the Central Govt. as well. Such dual / double discretions to waive the applicability of statutory stipulations governing prescribed requirements per se is bad in the eyes of the law.**

4. IMA strongly objects to **NEXT examination**—

a. For the system failure, the students are overburdened  
If the govt. still feels that a common examination is required before registration, a common Final year examination should be considered.

b. **Double standard** - while MBBS graduates have to undergo NEXT for registration, AYUSH graduates will get registration after a crash programme without NEXT or any common examination. There is no provision for AYUSH doctors practicing modern medicine to undergo licentiate exam. This amounts to restricting post MBBS students to practice and allowing half-baked AYUSH doctors with bridge course to start practicing.

c. Denial of right to health ensured in the constitution- in PHC and Sub Centres Govt is already deploying AYUSH doctors where as MBBS Doctors after passing NEXT is proposed to be deployed in urban areas.

5. **Undemocratic and Non representative** character of NMC

The Chairman of the NMC is armed with unquestionable powers to be the final authority and vested with powers for exemption from various clauses of the Bill. In MCI it is the executive committee and the general body which decide on issues concerning medical education and finally the government approval, the 3-tire decision making provision should be maintained.

The composition of the four autonomous boards prescribed under the Bill does not include any elected member there under. **Each board will have only three nominated members one president and two members and that too with full powers to recognize or derecognize a medical college, powers today vested with 130 members in the IMC Act**

Present MCI is a representative body with representatives from central government (8), state representatives (one from each state), state council's professional doctors (one each), representatives from each health university etc. covering all stake holders.



**Composition of the National Medical Commission:** Section 4 provides for the composition of the National Medical Commission, which will have a) a chairperson b) 12 Ex-officio Members c) 11-part time members d) an Ex-Officio Member Secretary. Thus, it would have an effective membership of 25 along with the Chairman of **which only 5 members will be elected** (Part Time Members who will be elected by the registered medical practitioners from among themselves from such regional constituencies and in such manner as may be prescribed).

Therefore, the proposed commission will have 1/5th members (20% elected members and 80% appointed / nominated members). It is for this reason it will not have a desired 'representative character' with reference to 'elected and nominated / appointed members'

The IMC Act provision for autonomy and has 1/3 of its members as elected members from registered Modern Medical Practitioners. It is the right of the Modern Medical Practitioners to elect its representatives in the MCI / NMC. This right should be restored by at least having one representative from each state / union territory.

**Composition of Autonomous Board:** The Section 17(1) of the proposed NMC Act stipulates that each autonomous board shall consist of President and two members. The composition does not provide for inclusion of any elected member therein which goes to indicate that the membership of the said Boards would be totally appointed / nominated without any representation of an elected member and thus they would not have any representative character as is desired and warranted.

IMA demands that each autonomous board should have an elected representative.

Functionally commission would be framing guidelines for determination of Fee in respect of such proportion of seats **not exceeding 40% in the private medical institutions** and deemed universities which are governed under the provisions of this proposed Act. This operationally means that the fee regulation would be limited to a maximum of 40% seats in the private medical institutions and deemed universities, **which is difficult to understand as to why such a ceiling and furthermore it could be anything from nil up to 40% which is paradoxical in nature. This will also have political implications and can be a root cause of future corruptions.** By allowing 60% of MBBS seats to be filled by management quota government through NMC will be denying poor medical aspirant's admission to MBBS. Medical education will become very expensive and unaffordable to ordinary students.

6. **Central Govt. empowered to issue directions:** Although, autonomy is expected to be a hallmark of the National Medical Commission Bill, 2017 and the Boards there under are called as, "Autonomous Boards" in reality the same is a misnomer as under section 44(1) in the said proposed Bill the Central Govt. would be entitled to **give directions to the Commission and autonomous boards on all the questions of policy which would be binding for the commission and autonomous Boards to comply.**

7. **Encroachment on the federal nature of the constitution of INDIA :** Section 45 of the proposed bill further stipulates that the Central Govt. would be within its rights to give such direction it may deem necessary **to the State Govt. for carrying out all or any of the provisions of this proposed Act and State Govt. shall comply with such directions** is also undermining the authority of the State Govt. and is inconsistent with the cardinal principles governing the federal polity as stipulated in the Constitution of India.

Section 10 (D) takes away the autonomous status of state medical councils " (d) promote, co-ordinate and frame guidelines and lay down policies by making necessary regulations for the proper functioning of the Commission, the Autonomous Boards and the State Medical Councils; and (f) take such



measures, as may be necessary, to ensure compliance by the State Medical Councils of the guidelines framed and regulations made under this proposed Act for their effective functioning under this Act.

8. **ACCREDITATION COUNCIL** - as is in existence even for art and science colleges should be added to NMC. The inspection at the time of starting a medical college will be assessing only infrastructural facilities and manpower. But the accreditation council assess the standards of medical teachings, pass percentage and student performance which in effect will assure uniform minimum standards in medical education and there will be no need for NEXT (National Exit Exam).

9. **MEDICAL GRANTS COMMISSION** also should be added in NMC to encourage research, teachers' career advancement, and funding teachers training programs
